"It is specifically the causal evidence and biological plausibility that was missing, linking RF EMF Radiation to adverse health effects. There are no circumstances where a lobbyist or politician would approach me. We are codes, standards and science without compromise. That is how I am associated with the most advanced medical education in the world. We all investigated each other.

I am not on this topic to be people's friend, my job includes saving fools from themselves. Hold me accountable, we are right, they are wrong and the world is in a lot of trouble that really has international security ramifications for all countries. There is nothing dumber in the world a collective pack of idiots could have done by allowing the microwaving of the planet for ease of communications.

Share and hold us all accountable. For those that want to disagree with me, tell them to technically disqualify me and that doesn't exclude the plastic head people.

existence is atoms and molecules, high speed RF EMFs and even 60 Hz(single power lines) have a profound affect on atoms and molecules the EMFs interact with.

Pass this off to MPs for what it is, an unprecedented emergency where damage is measurable by the second. EMFs require a qualified electrical interpretation first.

There are reasons we wire the world and confine EMFs to a known insulated conductor. These RF EMFs are an invisible electromotive force that is NOT supposed to hit you at all. When 900 MHz = 900 million cycles per second. Those RF EMFs associated with that antenna will oscillate violently 1.8 billion times per second, Imagine flipping a baby end for end 1.8 billion times per second. All of our work is science and sciences are supposed to compliment each other, not compete. Science professionals also have to be careful if speaking beyond their areas of expertise.

It took 15 years for health education administration for the Integrative Health Forum to give me my title of Chief International Science Advisory Board(14,000 members). My science background includes the structure of all matter which is the basis of all sciences. This group puts on the most advanced education in the world providing sight of energy using non invasive radiology.
